# ACCREDITATION HELP KIT



### Meet Your Legal Obligations by 1st March 2023 and Stay Accredited

This Accreditation Help Kit consists of guidance/training notes and template fill-the-gaps forms for every part of the Management Information System (MIS) and Maintenance Management System (MMS) as required and overseen by Transport Safety Victoria.

Approximately 50 pages of MIS documentation and 30 pages of MMS documentation, PLUS guidance notes and templates for other necessary compliance material such as Child Safe Standards overseen by Commission for Children and Young People.

#### MIS documentation includes:

- Safety policy
- Governance and internal control arrangements
- Documented safety accountabilities and authorities
- Information management process
- Safety information communication process
- Alcohol and drug management policy
- Hazard, risk and change management processes, including a Risk Assessment Register
- **Emergency management process**
- Process to establish bus safety worker competence
- Processes for incident reporting and investigation
- Internal audit procedure

#### MMS documentation includes:

- Accountabilities and authorities
- Competence
- Maintenance
- Inspections
- Defect reporting and clearance
- Records

Electronic access to the BusVic Accreditation Help Kit, including guidance material:

Access is for 12 months, and includes emails to you about any updates to the Help Kit during that period.
